RULES, REGULATIONS AND RESPONSIBILITIES OF EXHIBITOR CONTRACT

1. AGREES TO PAY BOOTH FEE OF \$30.00 PER SHOW DATE OR \$50.00 FOR BOTH SHOWS. NON-REFUNDABLE EVEN IF EXHIBITOR IS UNABLE TO ATTEND. THIS IS A RAIN OR SHINE EVENT.
2. 10 X 10 BOOTHS WILL BE ASSIGNED.
3. SHOW DATES ARE MAY 22 AND SEPTEMBER 25. SET UP IS 8:30-9:30. ALL EXHIBITORS MUST BE SET UP, PRICED AND READY BY 10:00.
4. TAKE DOWN IMMEDIATELY FOLLOWING SHOW SAT AND VACATE PARK NO LATER THAN 5:00PM THAT SAME DAY. NO EARLY TAKE DOWN.
5. EXHIBITORS ARE REQUIRED TO BE AWARE OF AND TAKE ACTION AGAINST SHOPLIFTING OCCURRING IN THEIR BOOTH AND WILL BE IN ATTENDANCE OF THEIR SPACE DURING THE ENTIRE SHOW.
6. DURING ENTIRE SHOW EXHIBITORS WILL KEEP MERCHANDISE WITHIN ASSIGNED AREAS, AND ALL ACTIVITY IS TO TAKE PLACE WITHIN THE AREA OF GAZEBO PARK, ALSO KEEP THEIR SPACES NEAT IN APPEARANCE
7. AGREES TO REMOVE AND TAKE WITH ALL TRASH BELONGING TO THEM, CLEAN THEIR AREA BEFORE LEAVING PARK AND KEEP ALL BACKSTOCK AND PACKING PRODUCTS STORED OUT OF SIGHT.
8. WILL NOT SELL ANY OFFENSIVE OR POLITICALLY INCORRECT MERCHANDISE. MERCHANDISE MUST BE CLEAN, IN GOOD CONDITION, CLEARLY PRICED, IN KEEPING WITH THE SEASON, AND PRICE RANGE OF AN OPEN AIR MARKET .
9. WILL PARK IN DESIGNATED EXHIBITOR AREA AND NO MOTORIZED VEHICLES ARE PERMITTED IN THE PARK AT ANY TIME. WHEN USING TENTS THEY MUST BE PROPERLY SECURED.
10. EXHIBITORS WILL KEEP ISLES FREE & CLEAR AND WILL MAKE ACCESS IN AND OUT OF BOOTH AS EASY AS POSSIBLE.
11. NO ALCOHOLIC BEVERAGES ALLOWED ON PREMISES.
12. EXHIBITORS ARE SOLELY RESPONSIBLE FOR THEIR VALUABLES AND SECURITY OF THEM .
